I will indemnify, defend and hold TTBR harmless from and against any claims, lawsuits, injuries, damages, losses, judgments, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for TTBR, or my breach of TTBR's rules, regulations, policies and programs.
3. If I stop being a volunteer for Tall Tails Beagle Rescue, Inc. for any reason, or upon request from TTBR at any time, I will promptly return all of the TTBR's supplies, equipment, records, monies, and other items in good, clean condition.
4. I understand and agree that TTBR may refuse volunteer applications for any reason.
5. I have accurately and truthfully completed this volunteer application and agreement.
6. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon your and our heirs, assigns, successors, personal representatives and executors.
